Waiver and Release of Liability for Swim and Fitness Facilities

Members are entitled to use of Swim & Fitness Facilities including Indoor Pool, Hot Tub, Sun Deck, and Fitness Room. Use of Coolfont Lake is NOT included in membership.

In consideration of my use of the swim and fitness facilities provided by Coolfont Resort LLC (hereinafter "Coolfont Resort"), I expressly agree and contract, on behalf of myself, my heirs, executors, administrators, successors and assigns, release Coolfont Resort from any liability arising from personal injuries (including death) sustained by me or my child/ward in, on, or about the premises, or as a result of the use of the pool or facilities, regardless of whether such injuries result, in whole or in part, from negligence of Coolfont Resort.

By the execution of this agreement, I accept and assume full responsibility for any and all injuries, damages (both economic and noneconomic), and losses of any type, which may occur to me or my child/ward, and I hereby fully and forever release and discharge Coolfont Resort, its insurers, employees, members, associates, from any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of the use of said pool and fitness facilities.

I expressly agree to indemnify and hold Coolfont Resort harmless against any and all claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise from injuries or damages sustained by me or my child/ward. I agree to be solely responsible for the safety and well-being of my child/ward and /or myself.

I understand that Coolfont Resort does not provide certified lifeguards, instruction, or assistance for the use of the pool facilities and fitness equipment. I agree to comply with all rules imposed by Coolfont Resort regarding the use of facilities and equipment. I agree to conduct myself in a controlled and reasonable manner at all time, and to refrain from using equipment in a manner inconsistent with its intended design and purposes.

I understand and acknowledge that the use of the pool and fitness equipment involves risk of serious injury, including permanent disability and death. I hereby certify that I know of no medical problems that would increase myself of my child's/ward's risk of illness or injury as a result of use of the Coolfont Resort pool facilities and/or fitness equipment.

I understand and agree that Coolfont Resort is not responsible for property that is lost, stolen or damaged while in, on, or about the premises. I have read the foregoing waiver and release of liability and have voluntarily executed this document with full knowledge of its content.

Coolfont Resort Swim & Fitness Rules

- 1. All members must sign in at Treetop Registration Front Desk. Members must write legibly and include their pass number.**
- 2. No outside alcohol or coolers.**
- 3. No pets in facilities unless it is a documented service animal.**
- 4. No glass in swim facility at any time.**
- 5. No running, throwing objects, pushing, dunking others, or general rough play.**
- 6. No diving into pool or hot tub.**
- 7. No loud music.**
- 8. Coolfont Staff has the right to caution members acting inappropriately. Members acting inappropriately may also be asked to leave the facilities.**
- 9. Please clean up after yourself and your family.**
- 10. Guests of members may purchase a day pass at Treetop Registration Desk.**
- 11. Swim or fitness hours may be shortened or extended due to inclement weather, extra maintenance, or special functions.**
- 12. Members and guests must wear appropriate clothing.**
- 13. All persons using the pool or hot tub must take a cleansing shower before entering.**
- 14. Any person having a skin disease, sore or inflamed eyes, nasal or ear discharge or any communicable disease shall be excluded from using the pool or hot tub. Persons wearing bandages, or with open blisters, cuts, or sores may not use the pool or hot tub.**
- 15. Members or guests under the age of 18 must be accompanied by an adult or person 18 years of age or older.**
- 16. Rafts, floats, water guns etc. are not permitted in the pool. Arm floats and training floats are permitted.**
- 17. No profanity or vulgar language is permitted. Be respectful!**
- 18. A swim diaper must be worn by children not yet potty trained.**
- 19. Only Members listed on the Membership Agreement, and who are current on their membership fees, have the right to use Swim & Fitness Facilities.**
- 20. Sharing passes with non-members is prohibited.**
- 21. Members must have their pass with them when using the facilities.**

I have read and fully understand the above rules and agree to them. Violation of any rules may result in immediate forfeiture of membership and membership fees paid.
